# Carlton City Council Meeting Minutes Wednesday February 8, 2017

# 1.00 Call to Order & Pledge of Allegiance 6:00pm

Mayor Bureau called the meeting to order, the time being 6:00 pm.

A Motion was made by Councilor MacDonald and seconded by Councilor Jorgenson to approve the Consent Agenda with the following changes: update 9.14 on the January 11, 2017 meeting minutes to include the verbiage the City Council is committed to replacing the utilities underneath County Road 1 within the next five (5) to seven (7) years since Carlton County is willing to hold off on repairing the road until that time; correct the exhibit to show wages for Mark Remington @ \$8.00/hr. The motion passed unanimously.

Mr. DesMarais was present to introduce himself to the new City Council Members. Councilor Gustafson questioned Mr. DesMarais about lining the manholes on 6<sup>th</sup> Street. Mr. DesMarais and Public Works Superintendent explained lining the manhole is not a good financial option as it does not solve the problem of the water line running through the manhole. The 6<sup>th</sup> Street Water and Sewer Utilities are listed as the third (3<sup>rd</sup>) project on the Capital Improvement Plan and will need to be replaced sometime in the near future.

## 9.01 Joint Powers Board (JPB)

The next step is interim financing and project design. Mr. Soden-Groves voiced his concerns about paying for the interim financing if Grant money would not come through. Interim financing is needed to get project design done so the project is "shovel ready" when grant money is available.

## 9.09 2017 Fee Schedule - Cemetery, Water/Sewer Rates and Fine Schedule

**A Motion** was made by Councilor Theisen and seconded by Councilor Gustafson to raise the cremation burial price to \$400.00, after hours (after 4pm) and weekend burials will be an additional \$75.00 and cremation winter burials \$600.00 or actual costs, whichever is greater. The motion passed unanimously.

**A Motion** was made Councilor Jorgenson and seconded by Councilor Gustafson to raise water rates 2% and sewer rates 3%. The motion passed unanimously.

**A Motion** was made by Councilor Jorgenson and seconded by Councilor Gustafson to have the fine schedule state "as allowed by State Statute." The motion passed unanimously.

#### 9.10 Flood Plain Ordinance

The former Thomson floodplain map should stay the same as the 1977 map and the City of Carlton should add the section of land north of Inter Faith Care Center. Clerk Conway will contact the Department of Natural Resources (DNR) to have them prepare a Flood Plain Ordinance.

# 9.11 Paul Vernon – Reopen Conditional Use Permit Request

Mr. Vernon would like to reopen his request for a Conditional Use Permit for his property located behind Interfaith Care Center. He would like to build storage buildings on the site, which would be secured by fencing. Mr. Vernon explained that it is cost prohibitive to bring water and sewer to that location due to the slate rock. Councilor Jorgenson and Councilor MacDonald would like to see documentation supporting the water/sewer issue and would like pictures of storage units, fencing and landscaping. Councilor Theisen questioned what information was received from neighboring properties.

# 9.12 Wildland Fire Truck Bid Approval - Midwest Fire @ \$108,103.00

A Motion was made by Councilor MacDonald and seconded by Councilor Jorgenson to accept the bid for the Wildland Fire Truck in the amount of \$108,103.00. The motion passed unanimously.

# 9.13 Approval of Fire Department Officers and Captains

**A Motion** was made by Councilor Theisen and seconded by Councilor MacDonald to approve the recommendations of the Fire Department Member for the following: Chief-Derek Wolf; 1<sup>st</sup> Chief – Lee Schelonka; 2<sup>nd</sup> Chief – Nick Schatz; Captains: Hannah Franck, Brent Bodie and Steve Schmidt. **A Motion** was made by Councilor Gustafson and seconded by Councilor MacDonald to approve Brent Bodie as Fire Relief Treasurer. The motion passed unanimously.

## 9.14 Fire Relief Representative

Councilor Theisen volunteered to be the second (2<sup>nd</sup>) Fire Relief Representative for the City of Carlton.

# 9.15 Third (3<sup>rd</sup>) and Fourth (4<sup>th</sup>) Quarter Ambulance Write-Off Corrections

**A Motion** was made by Councilor Gustafson and seconded by Councilor Theisen to correct the 2016 3rd and 4<sup>th</sup> quarter Ambulance write-offs as follows: 3<sup>rd</sup> Quarter \$165.352.59, 4<sup>th</sup> quarter \$ 146,256.04. The motion passed unanimously.

## 9.16 Western Lake Superior Sanitary District (WLSSD) – Inflow & Infiltration (I&I) Plan

**A Motion** was made by Councilor Gustafson and seconded by Councilor Jorgenson to approve the I&I plan as submitted. The motion passed unanimously.

Discussion was also held on the new WLSSD Ordinance being written. The Ordinance may require lateral sewer inspections when a home is sold and if the sewer is found defective the homeowner would be required to repair it. This could result in a significant cost to the homeowner. Northland Engineers will represent the City and state the Cities concerns to WLSSD.

# 9.17 911 Address Changes

Council members expressed support of the 911 address changes and directed Clerk Conway to proceed with the process of readdressing properties located within City limits.

**A Motion** was made by Councilor Theisen and seconded by Councilor Gustafson to approve the LG220 Gambling Application submitted by NWTF. The motion passed unanimously.
