\$25,001 - \$50,000	\$357.75 for the first \$25,000 plus \$9.00 for each additional \$1,000, or fraction thereof, to and including \$50,000
\$50,001 - \$100,000	\$581.00 for the first \$50,000 plus \$6.25 for each additional \$1,000, or fraction thereof, to and including \$100,000
\$100,001 - \$500,000	\$892.25 for the first \$100,000 plus \$5.00 for each additional \$1,000, or fraction thereof, to and including \$500,000
\$500,001 - \$1,000,000	\$2,891.50 for the first \$500,000 plus \$4.25 for each additional \$1,000, or fraction thereof, to and including \$1,000,000
\$1,000,001 and up	\$5,015.00 for the first \$1,000,000 plus \$2.75 for each additional \$1,000, or fraction thereof

**State Surcharge:** .05% x Total Valuation for values \$1,000,000 and less. For total values over \$1,000,000 the surcharge shall be in accordance with MN Statute 326B.148, Subdivision 1, Subparts (2) through (6)
