DEER HERD MANAGEMENT ARCHERY RULES AND APPLICATION

For hunters all hunters, harvest limits will follow current year MN DNR regulations for Zone 182 & 183. If using a cross bow hunter must be at least 60 years of age or provide a clear copy of their valid MN DNR disability permit or meet other criteria set forth by MN DNR.

Hunting permitted North of the Canal and on private property of 5 acres or more. Written permission must be obtained from the land owner.

Eligibility

- All hunters must have a valid MN DNR archery license.
- All hunters must possess a current year City of Carlton hunting permit.
- All hunters are required to follow current MN DNR hunting regulations.

Hunting Rules and Schedule

- **Archery rules and regulations will follow current MN DNR regulations.**
- All entrails must be removed and disposed of properly.
- **Hunting is prohibited:**
 - Within 250 feet of any dwelling or other building (residential or commercial) occupied by or for humans.
 - Within 500 feet of any property owned by Independent School District #93.
 - On any land owned by the City of Carlton unless otherwise indicated on map.
 - Within 100 feet of any publicly maintained City or State trail, park or improved roadway.

There is zero tolerance for violation of hunting rules. City hunting privileges will be suspended indefinitely for any violation.

I have read the above rules and agree to abide by them.

Assumption of the Risk / Waiver of Liability:

I, as the applicant, am fully aware of the inherent risks and hazards associated with hunting and the use of archery equipment. I knowingly and expressly assume the risk of my exposure to dangerous conditions. This assumption of risk does not extend to willful misconduct by the City or any person acting on its behalf.

I, as the applicant, understand and agree that neither the City of Carlton, nor any persons acting on its behalf, may be held liable in any way for any event which occurs in connection with the hunting activity which may result in harm, death, injury or other damage to me. This waiver of liability does not waive liability for any injuries that I obtain as the result of willful misconduct by the City or any person acting on its behalf. Further, I as the applicant will fully defend and indemnify the City of Carlton from any claims, lawsuits, causes of action, or judgements arising or resulting from my activities.
